**RESOLUTION 98-23  
ADOPTION OF INTERIM COMPENDIUM**

WHEREAS, Title I of P.L. 104-333 authorizes the Presidio Trust to adopt and to enforce such rules and regulations as may be necessary and appropriate to carry out its duties and responsibilities; and

WHEREAS, the Presidio Trust has adopted final interim regulations which have been published in the Federal Register on June 30, 1998 as 36 CFR Parts 1001, 1002, 1004, and 1005; and

WHEREAS, such regulations provide (at 36 CFR §1001.7(b)) for the compilation, in writing, of all designations, closures, permit requirements, and other restrictions imposed under the discretionary authority of the regulations; and

WHEREAS, pursuant to 36 CFR §1001.7(b), the staff of the Presidio Trust have drafted the Interim Compendium provided herewith, with direction from members of the Presidio Trust Board of Directors, and in consultation with the Secretary of the Interior and his designees; and

WHEREAS, pursuant to Title I of P.L. 104-333, on July 1, 1998, the Presidio Trust will assume administrative jurisdiction of the entire property designated as Area B on the map entitled "Presidio Trust Number 1," dated December 7, 1995; and

WHEREAS, it is necessary and appropriate for the Presidio Trust to have this Interim Compendium in effect prior to the time that it assumes administrative jurisdiction of this property in order to carry out its duties and responsibilities under the law; and

WHEREAS, this Interim Compendium incorporates all provisions of the existing Superintendent's Compendium for the Golden Gate National Recreation Area which currently apply to the property to be transferred to the Presidio Trust, and the Superintendent's Compendium has been subject to extensive prior public notice and comment; and

WHEREAS, this Interim Compendium makes no significant physical changes in the management of the property to be transferred to the Presidio Trust and it has not been possible for the Presidio Trust to provide for additional public comment on this Interim Compendium before it must become effective;

NOW, THEREFORE, BE IT RESOLVED, that the Presidio Trust Board of Directors hereby adopts the Interim Compendium provided herewith, to be effective immediately upon adoption; and

BE IT FURTHER RESOLVED, that pursuant to 36 CFR §1001.5(b), the Presidio Trust finds good cause for the adoption and effectuation of this Interim Compendium prior to the provision of additional opportunities for public comment; and

BE IT FURTHER RESOLVED, that the Board of Directors directs the Executive Director, in consultation with the General Counsel, to take such steps as may be necessary to have this Interim Compendium (including such non-substantive changes as may be necessary thereto) published and made available to the public as provided in 36 CFR §1001.7; and

BE IT FURTHER RESOLVED, that the Board of Directors directs the Executive Director, in consultation with the General Counsel, to take such steps as may be necessary to provide an opportunity for 60 days of public comment on this Interim Compendium, including publication of notice thereof in the Federal Register, to consider such comments, and to prepare a final compendium for the Board of Directors' consideration.
