## RESOLUTION 03-7 <u>ADOPTION OF FINAL INTERIM REGULATIONS AS FINAL REGULATIONS AND</u> <u>WITHDRAWAL OF PROPOSED REGULATIONS</u>

WHEREAS, Title I of P.L. 104-333 authorizes the Presidio Trust to adopt and to enforce such rules and regulations as may be necessary and appropriate to carry out its duties and responsibilities; and

WHEREAS, the Presidio Trust adopted final interim regulations at 36 CFR Parts 1001 -General Provisions, 1002 - Resource Protection, Public Use and Recreation, 1004 - Vehicles and Traffic Safety, and 1005 - Commercial and Private Operations, and published these in the Federal Register on June 30, 1998 at 63 Federal Register 35694; and

WHEREAS, the period for public comment on these final interim regulations closed on August 31, 1998; and

WHEREAS, the Presidio Trust Board of Directors reviewed the Environmental Assessment performed on the final interim regulations and adopted a finding of no significant impact concerning them pursuant to Resolution 98-20; and

WHEREAS, these final interim regulations remain in effect to this date; and

WHEREAS, the Presidio Trust issued proposed regulations concerning management of the area under its administrative jurisdiction (proposed 36 CFR Parts 1001 - General Provisions, 1002 - Resource Protection, Public Use and Recreation, 1003 - Vehicles and Traffic Safety, 1004 - Commercial and Private Operations, 1005 - Rights-of-Way, and 1006 - Presidio Trust Symbols), and published these proposed regulations in the Federal Register on September 18, 1998 at 63 Federal Register 50024; and

WHEREAS, the period for public comment on these proposed regulations closed on January 8, 1999; and

WHEREAS, the Presidio Trust held certain of these proposed regulations in abeyance until further notice by notice published in the Federal Register on January 19, 1999 at 64 Federal Register 2870;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Directors hereby adopts as final regulations the final interim regulations published in the Federal Register on June 30, 1998 at 63 Federal Register 35694, to be effective as final regulations 30 days after they are published as such in the Federal Register; and

BE IT FURTHER RESOLVED, that the Presidio Trust Board of Directors hereby withdraws its proposed regulations concerning management of the area under the administrative jurisdiction of the Presidio Trust (proposed 36 CFR Parts 1001 - General Provisions, 1002 -Resource Protection, Public Use and Recreation, 1003 - Vehicles and Traffic Safety, 1004 -Commercial and Private Operations, 1005 - Rights-of-Way, and 1006 - Presidio Trust Symbols), published in the Federal Register on September 18, 1998 at 63 Federal Register 50024; and

BE IT FURTHER RESOLVED, that the Board of Directors has determined that each of these actions is categorically excluded from further environmental review pursuant to 36 CFR Section 1010.7(a)(10); and

BE IT FURTHER RESOLVED, that the Board of Directors directs the Executive Director, in consultation with the General Counsel, to take such steps as may be necessary to have the final interim regulations (including such non-substantive changes as may be necessary thereto) published in the Federal Register forthwith as final regulations, together with a preamble describing their import and the Presidio Trust's compliance with applicable requirements, as well as a notice withdrawing the proposed regulations.
