## PRESIDIO TRUST CATERER AND FOOD TRUCK INSURANCE REQUIREMENTS

Caterer and Food Truck Insurance: Caterer and Food Truck operator(s) shall keep in force and effect the following insurance and shall provide the appropriate insurance certificates to the Trust within 90-days prior to the event date.

- a) A policy of commercial general liability insurance with a limit of not less than \$1,000,000. This insurance shall cover liability that may arise out of the condition of the Premises and Caterer's Parties (defined as all of Caterer's employees, subcontractors, vendors, and others who are on the Premises at the request of Caterer) use of or presence on the Premises, as well as liability assumed under an insured contract, including the tort liability of another assumed in a business contract.
- b) A policy providing \$1,000,000 "Full Liquor Liability" coverage, if alcoholic beverages are provided.
- a. Commercial Automobile Liability Insurance covering owned, hired and non-owned vehicles for which Permittee may be responsible with limits of no less than \$1,000,000 combined single limit per occurrence for Bodily Injury and Property Damage.
- c) Workers' Compensation in accordance with State of California law, and Employers' Liability with a limit of not less than \$1,000,000 each occurrence. However, if Caterer engages only independent contractors to participate in the delivery of catering services and uses no employees to deliver catering services at the event, the Trust will not require proof of workers' compensation or employers' liability.

## All required insurance shall:

- Be issued by one or more companies of recognized responsibility licensed to do business in the State of California
- 2. Name The United States, the Presidio Trust and its directors, officers, agents, subsidiaries, and employees as Additional Insured under the general liability insurance
- 3. Apply as primary insurance with respect to any other insurance or self-insurance programs afforded to the Trust
- 4. Be endorsed to provide a waiver of all rights of recovery and subrogation against The United States, the Presidio Trust and its directors, officers, agents, subsidiaries, and employees as Additional Insured
- 5. Declare any deductibles or self-insured retentions. All deductibles and retentions shall be paid in full by Caterer
- 6. Be expressly endorsed to state that coverage shall not be canceled, non-renewed or materially changed except after ten (10) days' prior written notice to the Trust prior to the date of this Permit. Caterer shall furnish the Trust with certified copies or certificate of insurance of all insurance policies, executed by duly authorized representative of each insurer, showing compliance with the insurance requirements of this Exhibit.

Caterers and Food Trucks shall enforce these same insurance provisions for each of its sub-contractors, vendors, or contracted parties. Caterer is solely responsible for damage to or loss of its business personal property, equipment, and vehicles.
