When to Apply Current or Former Codes

FOR PROJECTS IN VARIOUS STAGES OF DEVELOPMENT

Formerly adopted codes shall be used under these conditions:

- Projects that have commenced the Trust Design Review process prior to the effective date of the new codes are to continue using the former set of codes unless the tenant/ developer desires to use the new set and the Trust agrees to same in writing. (Note: a change in specified codes may require a modification to an existing letter of intent, DA or lease).
- 2. Trust-developed projects that have commenced the Design Review process prior to the effective date shall continue to use the former codes unless mutually agreed between the Trust and the A/E.

Currently adopted codes shall be used under these conditions:

- 3. For projects in pre-development (or in earlier stages of design development) without an executed letter of intent, lease agreement, or which have not started the Trust Design Review process, the new set of codes shall be used.
- 4. For Trust-developed projects which have yet to begin design, the new set of approved codes shall be used.
