PUBLIC SESSION

The Presidio Trust Board of Directors met via Teams video on December 3, 2024. This meeting was rescheduled from November 14, 2024.

Board Chair Mark Buell called the meeting to order at 6:02 p.m.

<u>Item 1 – Welcome</u>

Chair Buell opened the meeting by introducing new Trust Board members Chuck Collins and Patsy Ishiyama.
